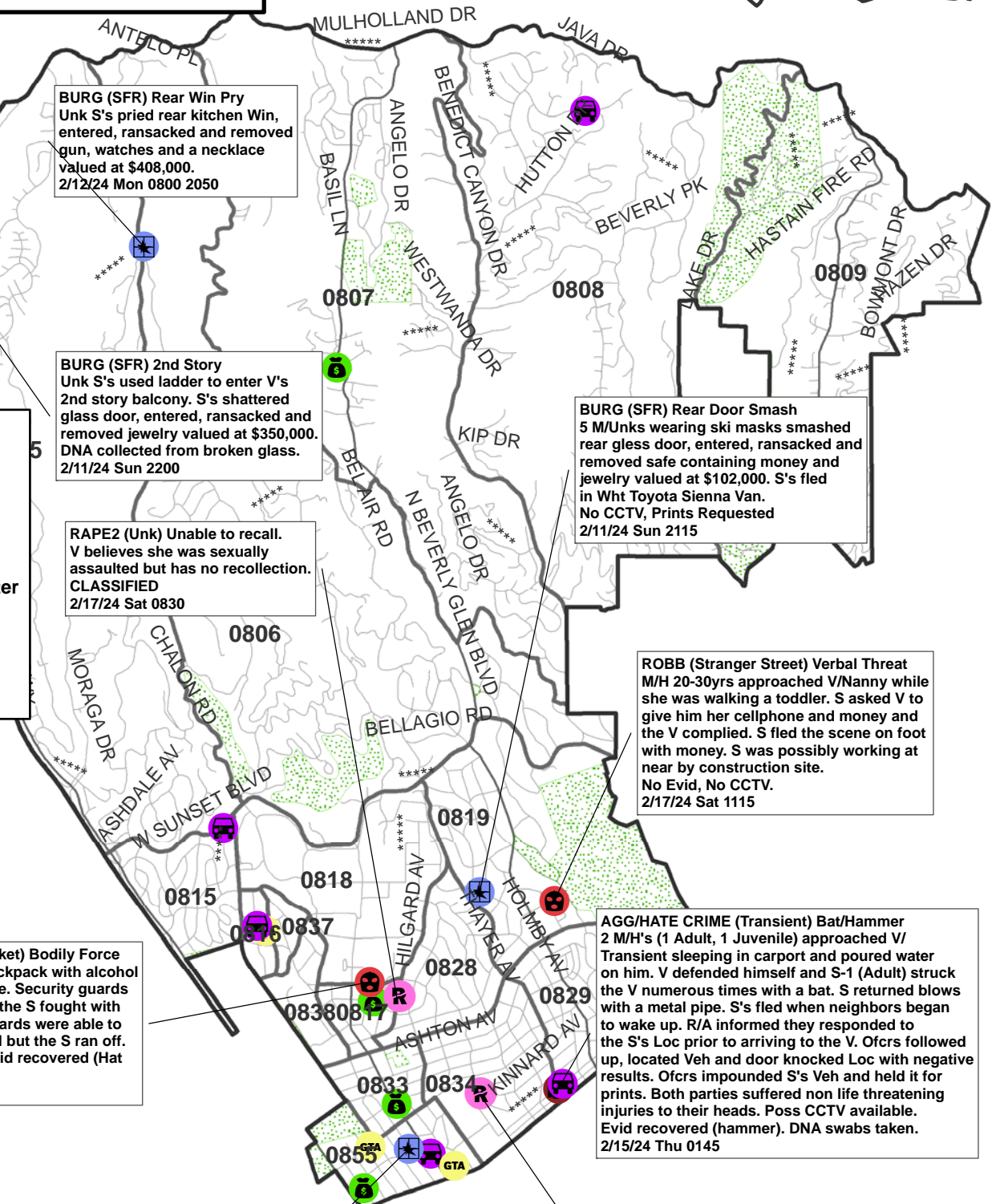
ROBB (Stranger Street) Verbal Threat
